Competitors entry statement

The FIA shall be responsible for administrating the entry form to be entered into by Competitors, together with the collection of the related entry fees.

Selection process:

a. Manufacturers:

The FIA shall open the **Manufacturers'** entries on **1 June 2016** and close them on **31 July 2016**. Each manufacturer shall pay an entry fee of **30'000** € per year. The official entry list of selected Manufacturers, with two cars per manufacturer selected, will be confirmed by the FIA, upon proposal of the Committee, before 31 August 2016.

b. Non-Manufacturers

The FIA shall open the **non-Manufacturers'** Competitors selection on **1 July 2016** and close them on **31 July 2016**. The official entry list of selected Competitors will be confirmed by the FIA, upon proposal of the Committee, before 31 August 2016.

Registration process:

Each selected manufacturer and competitor will be invited to register the teams selected for each car and the driver per car on or **before 16 September 2016**.

Each Team shall pay an entry fee of **6000 € per Car**. The official entry list of selected teams and drivers will be confirmed by the FIA, upon proposal of the Committee, **before 30 September 2016**. A common official release will be organised during the official Macau GP press Conference, not later than 31 October 2016.
