Introduction

Under the aegis of the FIA, in close cooperation with Macau GP, the objective of setting up the FIA GT World Cup is to create a showcase for GT manufacturers which will be the highlight of the season thanks to an exclusive format, attractive for drivers, generating considerable media coverage and a strong impact for the makes. FIA GT World Cup will become a reference event for GT drivers or manufacturers – an event that absolutely must feature among their record of achievement.

The philosophy of this World Cup must be that of an exclusive and exceptional event. For this, the choice of the attractive and mythic venue of Macau enables manufacturers to benefit from the extraordinary image of the event while at the same time attracting prestigious drivers, the very essence of the discipline.

For the FIA, the creation of a GT World Cup is a way of harmonising all GT championships taking place across the world, since it is imperative to contest a series recognised by the FIA and based on the FIA technical regulations in order to be eligible for qualification to the GT World Cup.

Competitors entry statement

The FIA shall be responsible for administrating the entry form to be entered into by Competitors, together with the collection of the related entry fees.

A. Manufacturers pre-entry registration

*The manufacturers' pre-entries registration will open **on 26 June 2015** and close **on 20 July 2015**. Each manufacturer may enter a maximum of 3 cars. The official entry list of selected manufacturers and the amount of cars per manufacturer selected will be confirmed by the FIA, upon proposal of the GT World Cup Committee, at the latest on 20 August.*

*Each manufacturer must pay an entry fee of **30 000 €** for the event, which is valid for the registration of 1, 2 or 3 cars and which is not refundable. This entry fee will allow the manufacturers to compete for the "GT World Cup Manufacturers Winner Title".*

B. Teams and drivers entry registration

*Each selected manufacturer will be invited to register the team(s) selected (one team may have from 1 to 3 cars) and the driver per car at the latest on **15 September 2015**.*

- *Each Team must pay an entry fee of **6000 €** per Car for the event.*
- *The official entry list of selected teams and drivers will be confirmed by the FIA, upon proposal of the GT World Cup Committee, before 30 September 2015.*
- *This entry fee will allow the drivers to compete for the "GT World Cup Drivers Winner Title".*
