**Offence** Breach of Appendix L, Ch IV, Article 2c and 12.1.1 (i) of the FIA International Sporting Code, failure to follow the Race Director's Event Notes 21.

**Decision** Deletion of the lap time shown as advised in the Event Notes.

**Reason** The Stewards reviewed video and received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with point 21 of the Race Director's Event Notes under the authority of Article 12.1.1 (i) of the FIA International Sporting Code.
