**Offence** Breach of Appendix L, Ch IV, Article 2c of the FIA International Sporting Code and failure to follow the Race Director's Race Notes 20.

**Decision** Deletion of the lap times shown in accordance with Article 12.1.1.i of the FIA International Sporting Code.

**Reason** The Stewards reviewed video and received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with point 20 of the Race Director's Event Notes and Article 12.1.1.i of the FIA International Sporting Code.
