The Stewards, having received a report from the Team Representative of DAMS, have considered the following matter and determine the following:

No / Driver 23 - Cem Bolukbasi

Competitor Charouz Racing System

**Time** 12:17

Session Race 2

Fact Altercation between the father of the driver of Car 23 and the driver of Car 16 and his

trainer in the F2 paddock area.

**Offence** Breach of Article 12.2.1.c of the FIA International Sporting Code.

**Decision** A fine of 5000 Euros to be paid immediately by the Driver. In accordance with Article

12.8.1 of the ISC, fines shall be paid within forty-eight hours of their notification by

means of bank transfer to the FIA.

In addition, the credentials of Yavuz Bolukbasi (father of the Driver of Car 23) are to

be withdrawn for the next Event in which the driver of Car 23 participates.

**Reason** The Stewards summoned and heard the team representatives (documents 48 & 49).

The following persons were present at the Hearing in addition to the panel of

Stewards.

DAMS: Remi Decourzent (Team Representative) & Francesco Martinez (Trainer of

Roy Nissany).

CHAROUZ: Kenny Kirwan (Team Representative), Yavuz Bolukbasi (Father of the

Driver of Car 23), Temucin Unalp (Manager of the Driver of Car 23)

After an on track incident between Cars 16 and 23 the father of the driver of Car 23, Mr Yavuz Bolukbasi, along with the driver's manager went to the DAMS Paddock tent. Mr Bolukbasi admitted that he lost his temper when he thought that the driver of Car 16 made a derogatory comment about his son. At the DAMS tent Mr Bolukabasi provoked a heated verbal exchange with the driver of Car 16. As the verbal exchange escalated the trainer for Roy Nissany became involved and there was some pushing and physical contact between the father and the trainer (Francesco). No punches were exchanged and the unwanted guests were removed from the area.

At no time will physical violence, nor the threat of such be tolerated. In keeping with ISC Art 9.15.1 Competitors are responsible for all acts of persons to whom they have given access to the Reserved Areas. The threat of violence and the actual minor scuffle that took place as initiated by Mr Bolukbasi are determined to be a breach of ISC 12.2.1(c). Accordingly the Driver is fined and the individual initiating the offence is sanctioned.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
