**Offence** Breach of Appendix L, Chapter IV, Article 2c and Article 27.3 of the FIA F2 Sporting Regulations.

**Decision** Deletion of the lap times shown in accordance with Article 12.4.1.e of the FIA International Sporting Code.

**Reason** The Stewards received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with Article 12.4.1.e of the FIA International Sporting Code by the Race Director Event Notes item 21.3 for track limit violations at Turn 16 the current lap and the next lap are deleted.
