The Stewards, having received a report from the Technical Delegate, have considered the following matter and determine the following:

Session Thursday 13 March - promoter activity

Fact On Thursday 13 March at 13:57 Campos Racing entered the pit lane and assembled and used the weighbridge while it was closed due to promoter activity in the support pit lane.

Infringement Breach of Article 12.2.1.i of the FIA International Sporting Code.

Decision A fine of 5000 Euros to be paid by the Team. A sum of 1000 Euros is to be paid immediately. The balance of 4000 Euros is suspended subject to no repeat of a similar infraction between now and the end of the 2025 F2 Season.

In accordance with Article 12.8.1 of the ISC, fines shall be paid within forty-eight hours of their notification by means of bank transfer to the FIA.

Reason The Stewards received a report from the Technical Delegate (document 15).

The FIA Technical Delegate explained that the Campos Racing mechanics used the weighbridge at 13:57 on Thursday 13 March, while it was closed due to the promoter activities in the support pit lane. In addition, he explained that the ramps were removed from the weighbridge, to facilitate the support series pit lane operations and to clearly indicate that the weighbridge was not available for the Formula 2 teams at this time. This instruction was issued to the teams on 5 March 2025.

The Stewards summoned and heard the team representative (document 25). The Team Representative admitted that the mechanics had reinstalled the ramps (without reinstating the securing fixings) and used the weighbridge during the unauthorised access period. The Team Representative apologised and explained that given the tight schedule his team had started working early and should not have.

The Stewards determined that Campos Racing personnel failed to follow the instructions and used the weighbridge outside the authorised hours. In addition, the Stewards took into consideration that the weighbridge ramps were not fitted by a member of the FIA F2 Scrutineering team and there was a potential for the equipment to be damaged.

Therefore, the Stewards decided to impose a 5,000 Euro fine to be paid by the Team. A sum of 1000 Euros is to be paid immediately. The balance of 4000 Euros is

suspended subject to no repeat of a similar infraction between now and the end of the 2025 F2 Season.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
